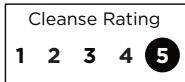
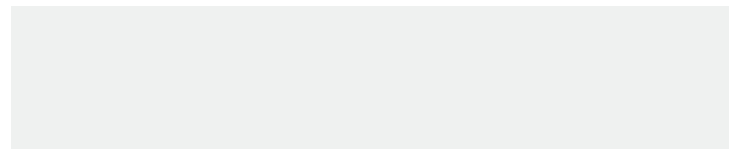
For use in industrial environments to remove extremely heavy soiling including ingrained oil, grease, bituman, carbon black and lubricants.
